Rental agreement for Consensus car Fiscal year 2022-2023

1. RENTAL AGREEMENT FOR CONSENSUS CAR

1.1	The agreement is established between Consensus –the student union for the medical faculty,
	orgnr. 8220003-1564 and, hereafter referred to as the
	renter. The renter must be a physical person with a valid driver's license with at least B
	competence or an equivalent thereof and be a member of the union.
1.2	The renter has the right to use the vehicle from (date, time): until
	(date, time):,
2.	RIGHTS AND RESPONSIBILITIES
2.1	If the car is damaged or for another reason cannot be made available to the renter in
	accordance with this agreement (for example if Consensus has urgent need for the vehicle)
	then Consensus shall communicate this to the renter as soon as feasibly possible. Should this
	be the case, Consensus does not oblige itself to provide alternate transportation, and the
	booking is instead cancelled.
2.2	The renter shall return the keys to the vehicle to Consensus at (date, time):,
	at the latest. The keys must always be returned to the Consensus board
	member responsible for the vehicle, unless otherwise specified in §5.
2.3	The driver's name, the date, the odometer reading at the start of the rental period, the
	distance travelled during the rental period and the renter's signature must be recorded in the
	driving journal. Consensus retains the right to forward any costs incurred from improperly
	recorded or absent information to the renter should the renter fail to properly record said
	information. The driving journal is kept within the vehicle.
2.4	The cost for renting the vehicle is 100 kr per two-hour rental period, or 400 kr per diem, in
	addition to 22kr per 10km distance travelled.
2.5	The renter is responsible for ensuring that the vehicle is returned with at least a half tank of
	fuel remaining. Consensus will compensate the cost of refueling the vehicle should this be
	needed, upon presentation of a valid receipt.
2.6	The renter is held responsible for the costs of any damage incurred to the vehicle during the
	rental period which the vehicle's insurance does not cover. Any deductibles or fines for traffic
	violations incurred during the rental period shall be paid by the renter.
2.7	Should roadside assistance be needed, any costs incurred shall be paid by the renter.
2.8	Other extraneous costs not otherwise specified, such as congestion charges, are paid by the
	renter.
2.9	The vehicle may not be used for the purpose of transporting intoxicated people.
2.1	
	The vehicle shall be returned in a good condition, with any garbage cleaned out after use. If
	the renter is found to be in violation of this paragraph, then Consensus shall have the right to

charge the renter a fee of 500kr. The renter shall also bear responsibility for paying any other

inappropriate behaviour, the Consensus board may vote to deny the person/organization the

costs incurred by violating this paragraph. Upon repeated violations and/or repeated

possibility of renting the vehicle. If the renter does not find the vehicle in a suitable condition upon starting their rental period, then this shall be reported to the Consensus board member responsible for the vehicle as soon as possible. Should the renter fail to do this, then the renter will be held responsible for any garbage that may be found in the vehicle after the end of the rental period, regardless of how it got there, and be charged accordingly.

- 2.11 The renter shall be mindful of the fact that they will be representing the union outwardly whilst using Consensus car. This means injudicious and irresponsible behavior in traffic can cause damage to Consensus reputation and will have due consequences in cases where the Consensus board deems appropriate. These stipulations apply during the entire rental period including when the car is not actively being driven, for example when it is parked. Consensus retains the right to charge the renter a punitive fee of up to 1000kr, should the renter be found to have violated §2.10. Consensus retains the right to forward any additional costs for Consensus incurred due to violations of §2.10 to the renter, in addition to a punitive fee of up to 1000kr.
- 2.12 Under certain circumstances during the reception period, organizers who belong to Consensus may be allowed to rent the vehicle at a reduced price. Each separate case is handled individually.
- 3. CONTRACT TIME AND TERMINATION
- 3.1 Consensus retains the right to cancel bookings up to 72 hours before the start of the rental period, but only under special circumstances.
- 3.2 The renter retains the right to, through contact with the Consensus board agreement signer, cancel a booking up to 48 hours before the start of the rental period. A late cancellation may result in the renter still being charged.
- 4. PAYMENT CONDITIONS
- 4.1 Payment shall be made by invoice to the renter.
- 5. ADDITIONS TO THE AGREEMENT
