1.1 The agreement is drawn up between Consensus – the Faculty of Medicine's student union,					
org. 8220003-1564 and, personnr	,				
hereinafter referred to as the borrower. The borrower must be a natural person, hold a driver's					
license with a qualification B or higher or equivalent and be a member of the union.					
1.2 The borrower has the right to use the vehicle from (date, time):,					
, up to and including (date, time):,,					

2. RESPONSIBILITY AND RIGHT

- **2.1** If the car breaks down or for some other reason cannot be made available to the borrower according to the agreement, for example if Consensus needs the car in an emergency or at short notice, Consensus shall, as far as possible, notify the borrower as soon as possible. Consensus is then not responsible for replacing the car, but the booking time will expire.
- **2.2** The borrower must return the key to Consensus' possession no later than (date, time): , Returns are always made to the Consensus car manager, unless otherwise stated under 5.
- **2.3** The mileage log must clearly state the driver's name, date, mileage for trip meters, the length of the trip and the borrower's signature. If this is not done, Consensus undertakes the right to invoice the Borrower for any other costs that may arise as a result. The mileage log is in the car.
- **2.4** The cost of the loan is **SEK 125 per two-hour period, SEK 350 per day, SEK 750 for a weekend** (Friday after 16.00 until Monday 08.00) **and SEK 15 per mile**.
- **2.5** The borrower is responsible for returning the **car with at least half a tank.** If refuelling is needed during the loan period, a receipt can be submitted to Consensus for reimbursement of the fuel cost.
- **2.6** The borrower is responsible for the costs of any damage caused to the car during the loan period, which is not covered by the car's insurance. Any deductible and fines for traffic violations are paid by the borrower.
- **2.7** In the event of an incident where assistance must be called, the borrower pays all costs incurred.
- **2.8** Other costs, such as congestion tax, are paid by the borrower.
- **2.9** The car may not be driven for the purpose of transporting intoxicated people.
- **2.10** Smoking, drinking alcohol or transporting animals is strictly forbidden in the car. The car must be returned in good condition, and all any rubbish must be cleaned out of the car after use. If the borrower violates this section, Consensus has the right to charge the borrower a fee of SEK 500. The borrower is also responsible for the other costs that may arise in the event of a breach. In the event of repeated violations and/or repeated inappropriate behavior, the board may deny the person/organization the loan of a Consensus car. If the borrower does not find the car in good condition at the start of the loan period, this must be reported to the Consensus car manager as soon as this is discovered. If this is not done, the borrower will be responsible for any rubbish that is found in the car after the end of the loan period, regardless of how it got there, and will be charged according to the above.

- **2.11** The borrower must take into account that they represent the corps when using the Consensus car. This means that injudicious and irresponsible traffic behaviour can damage Consensus' reputation, and will be subject to penalties where the Board deems it necessary. This applies throughout the loan period even when the car is not being driven, for example when it is parked. Based on this, Consensus undertakes the right to charge the Borrower a penalty, up to SEK 1000, if Consensus finds that the Borrower has violated clause 2.10. If additional costs arise for Consensus due to what is stated in clause 2.10, Consensus undertakes the right to charge the borrower for the cost incurred and in addition a penalty of up to SEK 1000.
- **2.12** In exceptional circumstances during the reception period, Promoters who are subject to Consensus may be able to rent for a discounted price. Each case is treated individually.

3. TERM AND TERMINATION

- **3.1** Consensus has the right to cancel the booking up to 72 hours before the start of the rental period, but only in special circumstances.
- **3.2** The borrower has the right to cancel the loan of the car up to 48 hours before the start of the rental period by contacting the signatory. If later, the signatory may be invoiced.

4. PAYMENT TERMS

4.1 Payment must be made against invoice to the borrower.

5. AMENDMENT TO THE AGREEMENT
