

Membership conditions

1. General membership conditions

By paying for a membership on the member's portal (<https://medlem.consensus.liu.se/>), you become a member of Consensus – Medicinska fakultetens studentkår (Consensus), Org. 822003-1564.

Registered students at the Faculty of Medicine and Health Sciences in Linköping have the right to be full members. This membership also includes membership of the section that is connected to the educational programme. By becoming a member, you authorise that your details are shared with the section in question, for the purpose of member mail-outs and membership checks. Non-registered students at the Faculty of Medicine and Health Sciences can be supporting members (see 2:4).

Membership of Consensus is valid when the student union has received payment. Membership fees are not reimbursed. By paying for membership, you authorise that your details are processed and retained by Consensus. When membership has been paid, Consensus reserves the right to use the member's details for statutory operations, service provision, administration, invoicing, customer service, analysis, development, information, marketing and for the execution of obligations according to legislation, agreement or government agency decision.

By paying for membership, you consent that your details may be disclosed to certain partners and government agencies. A member has the right to opt out of mail-outs from partners by notifying Consensus of this in writing.

By paying the membership fee, you consent that your details are forwarded to Studentkortet i Sverige AB, so that they can send you the student card and information on student discounts and benefits.

1.2 Obligations

Paying the membership fee as determined by the council. The membership fee includes the student union and section fees. The membership fee can be paid per term, year or other period, as determined by the council. Membership fees and payment periods are determined at the council budget meeting.

1.3 Rights

Every member has the right to attend council meetings. Members, except for supporting members, have the right to vote in elections for members of the council. Every member is eligible for positions of responsibility in the student union, apart from exceptions stated in Consensus's statutes. Members have the right to submit questions and motions to the council, and have these discussed. Members have the right to view the student union's meeting minutes and other documents that are not covered by confidentiality or that concern the student union's work with external parties, during ongoing negotiations and disputes. Members have the right to make use of the member benefits that the faculty student union offers its members.

2. Supporting membership

As a non-registered student at the Faculty of Medicine and Health Sciences, a person or legal entity with a link to the Faculty of Medicine and Health Sciences has the right to be a supporting member of the faculty student union. This membership can, if the supporting member wishes this, involve a supporting membership in one of the faculty student union's sections. People who are not enrolled at the Faculty of Medicine and Health Sciences at Linköping University, but at the Faculty of Science and Engineering, the Faculty of Arts and Sciences, or the Faculty of Educational Sciences at Linköping University may only be supporting members of Consensus if they are members of LinTek or StuFF.

2.1 Supporting members' obligations

Paying at least the student union and section fees, as determined by the council.

2.2 Supporting members' rights

Every supporting member has the right to attend council meetings.
